WHEREAS, pursuant to N.J.S.A., Shadid Jamal Webb, of 54 Vermont Avenue, Newark, New Jersey 07106, was appointed as a Constable pursuant to Resolution 7R9-b adopted at the April 19, 2017 Regular Municipal Council Meeting; and

WHEREAS, pursuant to N.J.S.A. 40A:9-125, Shadid Jamal Webb, of 54 Vermont Avenue, Newark, New Jersey 07106 must give a Bond, approved as to form, amount, and sufficiency by the Acting Corporation Counsel and the Municipal Council; and
