Amendment #1 Resolution 7R12-c adopted on September 6, 2012 for a contract increased the contract amount by \$975,000.00 for a new total contract amount not to exceed \$2,225,000.00.

Amendment #2 Resolution 7R12-c adopted on December 18, 2013 increased the contract amount by \$1,004,000.00 for a new total contract amount not to exceed \$3,229,000.00.

Amendment #3 Resolution 7R12-a adopted on December 2, 2015 increased the contract amount by \$275,000.00 for a new total contract amount not to exceed \$3,504,000.00, in addition to extending the contract period by twenty-two (22) months from December 18, 2014 through October 18, 2016.
