ORDINANCE OF THE CITY OF NEWARK, COUNTY OF ESSEX, STATE OF NEW JERSEY, AUTHORIZING THE TRANSFER OF CERTAIN PROPERTIES TO THE CITY OF NEWARK BOARD OF EDUCATION AND RELEASING A CERTAIN DEED RESTRICTION.

WHEREAS, in 1850, the New Jersey State Legislature established the Board of Education of the City of Newark; and

WHEREAS, the Board of Education (the "Board"), under the authority granted to it by N.J.S.A. 18A:1-1 et seq., owns and operates public schools in the City of Newark (the "City"); and

WHEREAS, the Board has closed numerous public schools within the City over the past few years, and several of those school properties are now vacant; and

WHEREAS, the Board wishes to dispose of certain of those properties that are vacant and are no longer needed for school use, portions of which are detailed below (the "Properties"); and

WHEREAS, upon receipt of title searches for the Properties prepared by Gibraltar Title Agency, it was discovered that the title to certain School properties are vested in the City and some are partially vested in the School and partially vested in the City; and

WHEREAS, the Board has exercised dominion and control over each of the Properties and operated them for educational purposes during the times that each of the Properties was in use as a school; and

WHEREAS, all of the Properties are reflected on the Tax Maps of the City of Newark as owned by the Board or its related entity, the Newark Public Schools; and

WHEREAS, it is believed that it was intended that any interests held by the City would be transferred to the Board, but such transfer never occurred, or occurred and was never recorded; and

WHEREAS, because the Properties were shown on the Tax Maps as under Board ownership, the City was unaware that it held any interest in any of the Properties; and

WHEREAS, the School has requested that the City transfer its interests in the Properties, as listed below in Section 1, to the Board; and

WHEREAS, the City may, pursuant to N.J.S.A. 40A:12-13(b)(1), authorize by ordinance the sale of City-owned real property or interests therein, not needed for public use to "any political subdivision, agency, department, commission, board or body corporate and politic of the State of New Jersey"; and

WHEREAS, the City has determined that the properties are not needed for public use, and wishes to release all right, title, and interest that it may have in the Properties at a price of One Dollar and Zero Cents (\$1.00) per property to the Board, upon certain conditions and with certain restrictions; and

WHEREAS, as certain Properties are listed on the National and/or New Jersey Registers of Historic Places ("Historic Properties"), and

WHEREAS, as a condition of the transfer of the Historic Properties and with the cooperation of the City, the Board shall comply with all applicable State and Federal rules and regulations related to the transfer of the Historic Properties; and

WHEREAS, the City did not authorize the Properties to be used for public recreational purposes as defined by the rules and regulations promulgated by the State of New Jersey's Green Acres Program, N.J.S.A. 13:8C-24 et seq.; and

WHEREAS, as a condition of the transfer of the Properties, the Board shall accept responsibility for any action which violates the rules and regulations promulgated by the Green Acres Program; and

WHEREAS, the Board has further discovered that the title to a certain property which the Board owns and no longer needs for school purposes contains restrictions imposed by the City limiting the use of the properties to school uses; and

WHEREAS, the Board has requested that the City release the restriction limiting the use of the following property to educational purposes only:

The property located at 452-460 Lyons Avenue, (South Ward) designated as Block 3731, Lot 1, formerly used as the Banneker School, with the restriction being contained in a Deed from the City of Newark to Bet Yeled School, The Jewish Folk School Newark, dated: August 22, 1968 and recorded at: Book 3616, page 334; and re-recorded in Book 3627, page 184; and

WHEREAS, the City wishes to convey its interests in the Properties to the School, and to release the restriction on the property located at 452-460 Lyons Avenue, on certain conditions and with certain restrictions.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

Section 1. The City hereby approves and authorizes the transfer of title to the School of the following portions of properties and/or entire properties:

- Those portions of the property located at 47-63 Miller Street, (South Ward) shown on the Tax Maps as a portion of Block 2794, Lot 26 and formerly used as the Miller Street School, which were transferred to the City by the following conveyances:
 - a. Into the Mayor and Common Council of the City of Newark, in the County of Essex and State of New Jersey by Deed from James L. Hayes and wife and others, dated August 3, 1872, recorded September 20, 1872 in the Essex County Register's Office in Book M16, page 380; and
 - b. Into the Mayor and Common Council of the City of Newark by Deed from Samuel Atwater and Charlotte S. his wife, Sarah E. Carter and Anson A. Carter individually and as Executors of the Will of Frederick A. Carter of the City of Newark in the County of Essex and State of New Jersey, dated January 9, 1892, recorded February 2, 1892 in the Essex County Registers' Office in Book Q26, page 294; and

<u>Section 2</u>. The City hereby approves and authorizes the release of the restriction limiting the use of the following property:

The property located at 452-460 Lyons Avenue, designated as Block 3731, Lot 1, commonly known as the Banneker School, with the restriction being contained in a Deed from the City of Newark to Bet Yeled, The Jewish Folk School Newark, dated: August 22, 1968 and recorded at: Book 3616, page 334; and re-recorded in Book 3627, page 184.

Section 3. The Mayor and/or his designee the Deputy Mayor/Director, Department of Economic and Housing Development is hereby authorized to execute quitclaim deeds in substantially the form attached as Schedule A and the related customary documents for the recording of such deeds, conveying the portions and/or the entirety of the properties as set forth in Section 1, and to release the restriction on the property set forth in Section 2, for the sum of \$1.00 for each deed, and to take any and all other necessary and appropriate action to effectuate those conveyances and release in accordance with and in furtherance of this Ordinance; and further, the Municipal Clerk is hereby authorized and directed to attest to the signature of the Mayor upon such documents, and is hereby further authorized and directed to affix the corporate seal of the City upon such document.

<u>Section 4.</u> This Ordinance is adopted under and by virtue of the provisions of N.J.S.A. 40A:12-13 in the Local Lands and Building Law.

<u>Section 5.</u> This Ordinance shall take effect upon final passage and publication in accordance with the laws of the State of New Jersey.

STATEMENT

This Ordinance provides for the transfer of all rights, titles, and interests the City of Newark may have in certain properties to the City of Newark Board of Education and releases a certain deed restriction.
