WHEREAS, pursuant to N.J.S.A. 40A:9-120, Orlando Vick, Sr., of 729 South 20<sup>th</sup> Street, Newark, New Jersey 07103, was appointed as a Constable pursuant to Resolution 7R8-a adopted at the April 19, 2017 Regular Municipal Council Meeting; and

**WHEREAS**, pursuant to *N.J.S.A.* 40A:9-125, Orlando Vick, Sr., of 729 South 20<sup>th</sup> Street, Newark, New Jersey 07103, must give a bond, approved as to form, amount, and sufficiency by Acting Corporation Counsel and the Municipal Council; and

**WHEREAS,** pursuant to  $\underline{\text{N.J.s.a.}}$  40A:9-121, a Constable must qualify, within thirty (30) days of the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years; and
