Ms. Rivera is a native of New York City. She began her career at WBGO in 1993 and for the next six years Ms. Rivera subbed in various day parts and hosts her own weekend shows such as, Sunday Morning Harmony, Latin Jazz Cruise and Weekend Jazz After Hours. While hosting these events, Ms. Rivera was a full-time employee at Greenwich House Settlement in New York City, in the agency's drug rehab component. After twenty years of service Ms. Rivera retired in 1998, from Greenwich House and she became a full-time employee in the Summer of 1999, as the evening host, Monday to Friday at WBGO. Not only does she host her nightly shows, but she continues to host the weekly program, Latin Jazz Cruise. Among Ms. Rivera's other credits, she has done voiceover work independently and for WBGO and from 2012-2014, she hosted inflight jazz and smooth jazz programs for China and Oman Airlines. Ms. Rivera has received honors and awards from "Chico O'Farrill" Lifetime Achievement Award for OutstandingContribution to Afro Cuban and Latin Jazz and New York People's Hall of Fame Award for Fostering Latin Jazz on the Radio in 2012. 
