NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. Pursuant to N.J.S.A. 40A:11-1 *et seq.*, and N.J.A.C. 5:34-7.29, the Purchasing Agent for the City of Newark, QPA, is authorized to utilize State Term Contract T-0099 Vehicles, Automobiles, Sedans/Crossover, which includes the following Contract

#A86922 with Hertrich Fleet Services, 1427 Bay Road, Milford, Delaware 19963 to purchase Seven (7) 2018 or newer Dodge Journey 4dr SE FWD vehicles for the City of Newark, for the period commencing upon the approval of this resolution by the Municipal Council until the date of complete delivery, no later than February 8, 2019.

- 2. All purchases, Purchase Orders and other related documentation shall be in accordance with the relevant State contract, State of New Jersey Standard Terms and Conditions, Method of Operation, and Third Party Agreement as contained in the State contract documentations and agreements.
- 3. There shall be no amendment of this resolution without the approval of the Municipal Council.
- 4. There shall be no advance payment on this State contract in accordance with N.J.S.A. 40A:5-16.
- 5. Funds for the purchase of these vehicles are encumbered on Purchase Order #0000130973, Fund 011-110-1101-71280-B2018 and Purchase Order 000033063 Fund 051-G16-E16T0-94310-B2016. This contract is for \$125,993.00.
- 6. This contract complies with Local Pay-to-Play Law, <u>N.J.S.A.</u> 19:44A-20.5 as a State contract award which constitutes a fair and open procedure.
- 7. The Purchasing Agent for the City of Newark, QPA shall forthwith file a duly executed copy of the Notice of Award by the State, attached hereto, any other required documents in the Office of the City Clerk, if applicable.
- 8. If required by State Law, the City Clerk shall provide the appropriate Notice of Award of this contract to the State Comptroller no later than twenty (20) business days following such award, in accordance with N.J.S.A. 52:15C-10 and the Notice of the Office of the State Comptroller dated May 7, 2008.
