- There shall be no advance payment on this State Contract in accordance with N.J.S.A. 40A:5-16.
- Funds for the purchase of this vehicle is encumbered on Purchase Order NW051-0000033292, Funding Source NW051-G13-D13MO-94310-B2013. This contract is for an amount not to exceed Seventeen Thousand Nine Hundred Ninety-Nine Dollars and Zero Cents (\$17,999.00).
