AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING FILLMORE BOTH SIDES, BETWEEN MARKET STREET AND RAYMOND **BOULEVARD. (EAST WARD).** 

WHEREAS, the residents of Fillmore Street have submitted a petition for Permit Parking on Fillmore Street, both sides, between Market Street and Raymond Boulevard, in the East Ward; and

WHEREAS, the Department of Engineering wishes to improve parking for the residents of Fillmore Street by creating Residential Permit Parking requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

That Section 23:5-14e, Parking by Permit Only in Designated Section 1. Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

Fillmore Street, both sides between Market Street and Raymond Boulevard (Hours: 24hrs. / Days: Monday-Sunday)

- Regulatory signs shall be erected and maintained by the City of Section 2. Newark.
- Section 3. Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.
- Section 4. This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.
- This ordinance does not require approval by the Commissioner of Section 5. Transportation.
