WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$10,000.00 for the Emergency Management Agency Assistance (EMAA) Grant and no adequate provision has been made in the 2019 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and
