WHEREAS, under the visionary leadership, hard work and sturdy stewardship of the late Reverend Dr. Willie A. Simmons and Reverend Dr. Samuel Austin, First Corinthian Missionary Baptist Church spearheaded affordable housing, new commercial development along the Springfield Avenue corridor and increased job growth, contributing greatly to the stabilization and revitalization of the

WHEREAS, through the unyielding and unwavering contributions of civic giants such as Reverend Dr. Willie A. Simmons and Reverend Samuel Austin, two (2) men of notable individual accomplishments and accolades within their own right, the City of Newark's re-emergence as a leading urban city is a testament to their lifetime of achievement and unselfish service.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Municipal Council hereby authorizes the honorary and ceremonial renaming of the intersection of 18th Avenue and South 10th Street as "Simmons/Austin Plaza".
- 2. The official name of the said streets shall remain 18th Avenue and South 10th Street in their entirety.
