**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL, OF THE CITY OF**

**NEWARK, NEW JERSEY, THAT:**

1. The term of the Constable appointment of James T. Morrison, 14 Yates Avenue, Newark, New Jersey 07112 is for a period of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
