**WHEREAS,** an emergency has arisen with respect to payment of the 2014 and 2015 Retroactive Pay for members of Fraternal Order of Police (FOP) and Superior Officers Association (SOA) and, no adequate provision was made in the 2016 budget for the aforesaid purpose, and NJS 40A:40-46 provides for the creation on an emergency appropriation for the purpose mentioned above; and

**WHEREAS,** the total amount of the emergency appropriations created, including the appropriation to be created by this resolution is \$6,691,316.00 and three (3) percent of the total operating appropriations in the budget for 2016 is \$17,200,532.00; and

**WHEREAS**, the foregoing appropriation together with prior appropriations does not exceed three (3) percent of the total operating appropriations (including utility operating appropriations) in the budget for 2016.

**NOW, THEREFORE, BE IT RESOLVED BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. An emergency appropriation be and the same is hereby made for the Salaries and Wages in the amount of \$6,691,316.00
2. That said emergency appropriation shall be provided for in full in the 2017 budget, and is requested to be excluded from CAPS, pursuant to NJS 40A:4-53.3c(1).
3. A copy of this resolution shall be filed with the Director of the Division of Local Government Services by the City Clerk of the City of Newark.
