**WHEREAS**, an emergency has arisen in Special Item of Appropriation in the amount of \$200,000.00 for the Brownfields Cleanup - Orbis Site, Lots 15 & 41 and no provision has been made in the 2015 Temporary Budget for the aforesaid purpose; and

**WHEREAS**, by Resolution 7R3-c(S) dated March 24, 2015, from the United States Environmental Protection Agency (USEPA), the City of Newark, was awarded \$200,000.00 to provide financial assistance to conduct environmental remediation activities at the City-owned property located at 41-45 McClellan Street; and

**WHEREAS**, N.J.S.A 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, emergency appropriation adopted in 2015 pursuant to N.J.S.A. 40A:4-20, including this resolution total...\$108,703,240.23.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. An emergency appropriation be and the same is hereby made for the following classification:
