**WHEREAS**, an emergency has arisen with respect to insufficient appropriations in Department of Public Safety Police and Fire Salaries and Wages and, no adequate provision was made in the 2018 budget for the aforesaid purpose, and N.J.S.A. 40A:4-46 provides for the creation of an emergency appropriation for the purpose mentioned above, and

**WHEREAS**, the total amount of the emergency appropriations created, including the appropriation to be created by this resolution is \$15,000,000 and three (3) percent of the total operating appropriations in the budget for 2018 is \$17,621,584, and

**WHEREAS**, the foregoing appropriation together with prior appropriations does not exceed three (3%) percent of the total operating appropriations (including utility operation appropriations) in the budget for 2018, and

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

By not less than 2/3 of all Governing Body members affirmatively concurring that in accordance with N.J.S.A. 40A:4-48:

1. An emergency appropriation is hereby made for the Department of Public Safety:

- A. Police Division - Salaries and Wages \$ 9,500,000
- B. Fire Division - Salaries and Wages 5,500,000

in the amount of \$15,000,000.

- 2. That said emergency appropriation shall be provided for in full in the 2018 budget, and is requested to be excluded from CAPS, pursuant to N.J.S.A. 40A:4-53.3c(1).
- 3. That an Emergency Note not in excess of the above amount be authorized pursuant to N.J.S.A. 40A:4-51.
- 4. That such note shall be executed by Danielle A. Smith, Chief Financial Officer, and by Kenneth Louis, City Clerk.
- 5. That such note shall be dated \_\_\_\_\_, 20\_\_\_\_, may be renewed from time to time, and such note and any renewals shall be payable on or before December 31, 20\_\_\_\_.
- 6. That two (2) certified copies of this resolution be filed with the Director of the Division of Local Government Services.

### **STATEMENT**

This legislation allows for the funding in the 2018 budget of unanticipated additional overtime for Police and Fire Divisions, the Police Class of 145 New Recruits and the expiration of the SAFER grant that transferred 38 Fire Fighters to the Current Fund.
