**WHEREAS**, an emergency has arisen in the Special Item of Appropriation in the amount of Sixty Thousand Dollars and Zero Cents (\$60,000.00), for Integrity, Inc.’s Certified Community Behavioral Health Center Primary Care Services Program and no adequate provision has been made in the 2023 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

**WHEREAS**, by the Notice of Award dated June 5, 2023, the New Jersey Department of Health and Community Wellness in collaboration with Integrity, Inc., awarded the City of Newark funds in the amount of \$60,000.00. The aforementioned program will provide funds for the provision of health care and supportive services to the residents of the City of Newark; and

**WHEREAS**, N.J.S.A. 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, emergency appropriation adopted in 2023, pursuant to N.J.S.A. 40A: 4-20 including this Resolution total.....\$451,388,059.43.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

- 1. The Governing Body by a two-thirds vote of its full membership hereby amends its temporary budget by making the following temporary emergency appropriation:
- 2. A temporary emergency appropriation be and the same is hereby made for the following classification.

**STATEMENT**

This Resolution establishes the temporary emergency appropriation for Integrity, Inc.’s Certified Community Behavioral Health Center Program FY 2023, in the amount of Sixty Thousand Dollars and Zero Cents (\$60,000.00). The State of New Jersey, Department of Health and Community Wellness awarded the funds. The project period is February 1, 2023 through January 31, 2024.
