## TE #39

WHEREAS, an emergency has arisen in the Special Item of Appropriation in the amount of One Million Seven Hundred Four Thousand Seven Hundred Dollars and Zero Cents (\$1,704,700.00) for FY 2023 Summer Youth Employment Program (SYEP) and no adequate provision has been made in the 2023 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose abovementioned; and

**WHEREAS**, by Resolution 7R2-f dated May 3, 2023, the City of Newark (the "City") has accepted FY 2023 Summer Youth Employment Program (SYEP) from New Jersey Department of Labor and Workforce Development, in the amount of One Million Seven Hundred Four Thousand Seven Hundred Dollars and Zero Cents (\$1,704,700.00) to provide funds for program operations; and

**WHEREAS**, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and.

**WHEREAS,** the emergency appropriations adopted in 2023, pursuant to <u>N.J.S.A</u>. 40A:4-20, including this Resolution total \$ 320,537,690.47.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Governing Body by a two-thirds vote of its full membership is hereby making the following temporary emergency appropriation.
- 2. An emergency appropriation be and the same is hereby made for the following classification:

- 3. Said emergency appropriation shall be provided for in the 2023 Budget.
- 4. A copy of this Resolution shall be filed with the Director of the Division of Local Government Services by the Acting City Clerk.
