**WHEREAS**, the City of Newark wishes to appoint Oliver Richard Mayson to serve as a Constable for a term of three (3) years.

## NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Oliver Richard Mayson, of Newark, New Jersey 07107, is hereby appointed as a Constable, in accordance with his application to serve civil and criminal warrants, written summonses, complaints, repossessions and lockouts.
- 2. Prior to carrying out the duties of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Municipal Council.
- 3. This appointment shall be for a term of three (3) years from the date of appointment or the expiration of the Constable bond, whichever occurs first.
