**WHEREAS**, pursuant to N.J.S.A. 40:9-120 et seq., the City of Newark may appoint up to fifty (50) Constables; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-121, the City of Newark may appoint a Constable for a term of three (3) years, unless the Municipal Council, by its resolution of appointment, fixes a one (1) year term; and

**WHEREAS**, the City of Newark wishes to appoint Oliver Richard Mayson to serve as a Constable for a term of three (3) years.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. Oliver Richard Mayson, of Newark, New Jersey 07107, is hereby appointed as a Constable, in accordance with his application to serve civil and criminal warrants, written summonses, complaints, repossessions and lockouts.
2. Prior to carrying out the duties of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Municipal Council.
3. This appointment shall be for a term of three (3) years from the date of appointment or the expiration of the Constable bond, whichever occurs first.

This Resolution authorizes the appointment of Oliver Richard Mayson, of Newark, New Jersey 07107, to serve as a Constable in the City of Newark for a period of three (3) years from the date of the appointment or the expiration of the Constable Bond, whichever occurs first.
