To foster initiatives, programs, and opportunities to reduce violence and strengthen relationships between law enforcement and Newark communities.

**WHEREAS**, the City of Newark (“City”) desires to apply for and obtain a New Jersey legislative “line item” grant from the New Jersey Department of Community Affairs (the “Department”) for approximately Five Million Dollars and Zero Cents (\$5,000,000.00) to carry out the “Brick City Peace Collective (BCPC) Grant” Project to foster initiatives, programs, and opportunities to reduce violence and strengthen relationships between law enforcement and Newark communities; and

**WHEREAS**, on or about March 8, 2024, the Mayor of the City of Newark did cause an application for such grant funds to be submitted to the Department (a copy of which is attached hereto and made a part hereof); and

**WHEREAS**, the Department has informed the City that the City’s application has been approved; and

**WHEREAS**, the Department requires that the City pass a Resolution authorizing the grant application before a grant agreement can be entered into which would then authorize the release of the grant funds to the City; and

**WHEREAS**, no municipal funds are required for the receipt or acceptance of the grant award.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Municipal Council does hereby authorize an application to the New Jersey Department of Community Affairs (the “Department”) for the Newark Brick City Peace 2024 grant.

2. The actions taken by the City of Newark (the “City”) to apply for the grant are hereby ratified from the date the application was submitted until the date of this authorizing Resolution.

3. The Municipal Council recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement , does further authorize the execution of any such grant agreement upon review, approval and signature by the Mayor of the City of Newark and/or his designee, the Business Administrator, and the Corporation Counsel; and also, upon receipt of the fully executed grant agreement from the Department, does further authorize the acceptance of the grant funds and the expenditure of the funds, pursuant to the terms of the grant agreement.

4. Be it further resolved that the persons whose names, titles, and signatures of the Mayor of the City of Newark and/or his designee, the Business Administrator are authorized to sign the application, and that they or their successors in said titles are authorized to sign the grant agreement and any other documents necessary in connection therewith.

5. The Mayor of the City of Newark shall file fully executed copies of the grant application and grant agreement in the Office of the City Clerk.

## **STATEMENT**

This Resolution ratifies and authorizes the Municipal Council, the Mayor of the City of Newark and/or his designee, the Business Administrator, to apply and submit a grant application and acceptance of \$5,000,000.00 for a New Jersey legislative “line item” grant funds from the New Jersey Department of Community Affairs to carry out the “Brick City Peace Collective (BCPC) Grant” project to foster initiatives, programs, and opportunities to reduce violence and strengthen relationships between law enforcement and Newark communities; further authorizing the execution of the grant agreement by the Mayor of the City of Newark and/or his designee, the Business Administrator. No municipal funds are required for the receipt or acceptance of the grant funds.
