AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING CRANE STREET BETWEEN DR. MARTIN LUTHER KING, JR. BOULEVARD AND SUMMER AVENUE TO THE EXISTING PERMIT PARKING AREAS DESIGNATED LIST.(CENTRAL WARD)

WHEREAS, the residents of Crane Street have submitted a petition for Permit Parking on Crane Street between Dr. Martin Luther King, Jr. Boulevard and Summer Avenue, in the Central Ward.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

Section 1. That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

Crane Street, both sides between Dr. Martin Luther King, Jr. Boulevard and Summer Avenue (Hours: 24hrs. / 7 Days: Monday-Sunday).

Section 2. Regulatory signs shall be erected and maintained by the City of Newark.

- **Section 3.** Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.
- **Section 4.** This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.
- **Section 5.** This ordinance does not require approval by the Commissioner of Transportation.

STATEMENT

This ordinance allows parking by permit only on Crane Street between Dr. Martin Luther King, Jr. Boulevard and Summer Avenue, in the Central Ward.
