**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

The term of the Constable appointment of Jamil Brewer is for a term of three (3) years from the date of his appointment or the date of expiration of the Constable Bond, whichever occurs first. The Constable Bond, in the amount of \$1,000.00 issued to Jamil Brewer, 263 Lehigh Avenue, Newark, New Jersey 07112, is approved as to form, amount and sufficiency.
