WHEREAS, the City of Newark (the "City") is involved in ongoing legal matters and therefore has a need to acquire Legal Services; and

WHEREAS, Legal Services are Professional Services, exempt from the requirement for public

bidding, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(i); and

WHEREAS, the Department of Economic and Housing Development issued a Request for Qualifications ("RFQ") for Redevelopment/Land Use Counsel Services on October 22, 2019; and

WHEREAS, the City of Newark received a total of five (5) proposals in response to its request by the RFQ due date on November 14, 2019; and

WHEREAS, Schenck, Price, Smith & King, LLP, 220 Park Avenue, P.O. Box 991, Florham Park, New Jersey 07932-0991, submitted a proposal and the Director of the Department of Economic and Housing Development found, based upon price and other factors, to be in the best interest of the City to accept the proposal of providing Legal Services for Redevelopment/Land Use Matters; and

WHEREAS, the City wishes to enter into a contract with Schenck, Price, Smith & King, LLP, to provide Legal Services for Redevelopment/Land Use Matters, in an amount not to exceed One Hundred Thousand Dollars and Zero Cents (\$100,000.00), for the period of March 12, 2020 through March 11, 2021; and

WHEREAS, the Local Public Contracts Law (<u>N.J.S.A.</u> 40A:11-1 et seq.) requires that notice of the award of contracts for "Professional Services" without competitive bidding must be published in a local newspaper; and

WHEREAS, this contract is for an amount over \$17,500.00 and is being awarded as a Fair and Open Contract pursuant to N.J.S.A. 19:44A-20.5; and

WHEREAS, the Municipal Council adopted the Contractor Pay-to-Play Reform Ordinance, R.O. 2:4-22C, which forbids the award of a contract to a Business Entity, as defined therein, which has made or solicited political contributions to Newark Municipal Candidates; office holders having ultimate responsibility for the award of a contract; candidate committees of the aforementioned candidates; political or political party committees of the City of Newark or County of Essex; continuing political committees or political action committees regularly engaged in the support of the City of Newark Municipal or County of Essex elections; and certain other political party or candidate committees, in excess of certain thresholds.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor and/or his designee, the Corporation Counsel are hereby authorized on behalf of the City of Newark to enter into and execute a contract with Schenck, Price, Smith & King, LLP, 220 Park Avenue, P.O. Box 991, Florham Park, New Jersey 07932-0991, to provide Legal Services concerning Redevelopment/Land Use Matters in an amount not to exceed One Hundred Thousand Dollars and Zero Cents (\$100,000.00) for the period of March 12, 2020 through March 11, 2020.
- 2. This contract is ratified from March 12, 2020 to the date of adoption of this resolution.
- 3. This contract is being awarded pursuant to the Fair and Open Procedures of the State Payto-Play Law (N.J.S.A. 19:44A-20.5), Local Public Contracts Law (N.J.S.A. 40A:11-5(1)(a) (i)); and is in compliance with the Contractor Pay-to-Play Reform Ordinance, R.O. 2:4-22C.
