**AN ORDINANCE AMENDING TITLE 2, ADMINISTRATION, CHAPTER 24, PERSONNEL PRACTICES AND POLICIES OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY (2000), AS AMENDED AND SUPPLEMENTED, TO REQUIRE ALL NEWARK SPECIAL LAW ENFORCEMENT OFFICERS TO BE A RESIDENT OF THE CITY OF NEWARK, NEW JERSEY.**

WHEREAS, the Municipal Council deems it in the best interest of the City of Newark to amend the existing residency requirements for the appointment of Special Law Enforcement Officers to now require that all such persons at the time of appointment shall be bona fide residents of the City of Newark and to grandfather those individuals that may not be residents of the City of Newark but who seek immediate reappointment; and

WHEREAS, the Municipal Council deems it in the best interest of the City of Newark, to henceforth from the date of the adoption of this ordinance to require a bona fide residence in the City of Newark for all persons, excluding those grandfathered by the terms of the ordinance, who shall be appointed as Special Law Enforcement Officers.

**NOW, THEREFORE, BE IT ORDAINED, BY THE MUNICIPAL COUNCIL OF THE CITY OF**

**NEWARK, THAT:**

Section 1. Title 2, Administration, Chapter 24, Personnel Practices and Policies of the Revised General Ordinances of the City of Newark, New Jersey (2000), as amended and supplemented, Section 1.4 is hereby amended to read:

~~Seventy-five (75%) percent of [A]~~ All Special Law Enforcement Officers who shall hereafter be so appointed, are hereby required as a condition of their appointment to have their place of abode in the City of Newark and to be bona fide residents therein. A bona fide resident, for the purpose of this Section, is a person having a permanent domicile within the City of Newark and one which has not been adopted with the intention of again taking up or claiming a previous residence acquired outside of the City limits. All Special Law Enforcement Officers, seeking immediate reappointment prior to the expiration of their term of appointment or no later than three (3) months from the expiration of their term, shall not be subject to the residency requirement.

Section 2. Any prior ordinances or parts thereof in conflict or inconsistent with this ordinance are hereby repealed.

Section 3. If any part of this ordinance is declared unconstitutional or illegal, the remaining provisions shall continue in full force and effect.

Section 4. This ordinance shall take effect upon final passage and publication in accordance with the laws of the State of New Jersey.

STATEMENT

This ordinance requires all Special Law Enforcement Officers to live in the City of Newark, New Jersey.
