**WHEREAS,** the Municipal Council of the City of Newark wishes to continue supporting the Summer Youth Work Experience Program; and

**WHEREAS,** Newark Public Schools require that the City of Newark submit a Hold Harmless and Indemnification Agreement to indemnify Newark Public Schools from any claims arising out of the use of school properties that are related to the Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Municipal Council of the City of Newark supports the efforts of the Newark One Stop Career Center/NewarkWORKS, to conduct its Summer Youth Work Experience Program 2013 application certification at the following Newark Public School facilities throughout the City of Newark on the following dates:

4. Copies of this resolution and the fully executed Hold Harmless and Indemnification Agreements shall be filed in the Office of the City Clerk by the Acting Director of the Newark One-Stop Career Center/NewarkWORKS.
