WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division Local Government Services may approve the insertion of any Special Item of Revenue in the budget of any local unit when such item shall have been made available by law and the amount thereof shall not have been determined at the time of the adoption of the budget, and may approve the insertion of an appropriation item of equal amount for the purpose of carrying out the purposes of the law making such item of revenue available for expenditure; and

WHEREAS, by Resolution # 7R2-h adopted on September 7, 2023, the City of Newark has accepted Temporary Assistance for Needy Families (TANF) and General Assistance/Supplemental Nutrition Assistance Program (GA/SNAP) Grants in the amount of Four Hundred Seventy-Three Thousand Three Hundred Fifteen Dollars and Zero Cents (\$473,315.00) from the New Jersey Department of Labor and Workforce Development and Economic Opportunity to provide assistance in job placement for participants and disbursement of Workforce Investment Funds; and

WHEREAS, the New Jersey Department of Labor and Workforce Development and Economic Opportunity has made available \$473,315.00 for the TANF and GA/SNAP Grants (City-wide).

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. That in accordance with the provisions of N.J.S.A. 40A:4-87, the City of Newark hereby requests the Director of the Division of Local Government Services to approve a budget insertion in the amount of Four Hundred Seventy-Three Thousand Three Hundred Fifteen Dollars and Zero Cents (\$473,315.00) and an appropriation of an equal amount for the budget year 2023 as set forth in Schedule A, attached hereto and made a part hereof.
2. That the aforesaid insertion is, in the opinion of the Governing Body, warranted and authorized by N.J.S.A. 40A:4-87 and are necessary for the orderly operation of the municipality.
3. A copy of this Resolution shall be filed with the Director of the Division of Local Government Services by the City Clerk of the City of Newark.

STATEMENT

This Resolution is establishing an appropriation and revenue in the 2023 City of Newark's Budget for the Temporary Assistance for Needy Facilities (TANF) and General Assistance/Supplemental Nutrition Assistance Program (GA/SNAP) Grants in the amount of Four Hundred Seventy-Three Thousand Three Hundred Fifteen Dollars and Zero Cents (\$473,315.00) from the New Jersey Department of Labor and Workforce Development and Economic Opportunity. The project period is July 1, 2023 through June 30, 2024 (City-wide).
