WHEREAS, Legal Services are Professional Services and are exempt from the requirements for public bidding pursuant to the Local Public Contracts Law, more specifically, <u>N.J.S.A</u>. 40A:11-5(1) (a)(i); and

WHEREAS, the Municipal Council, by Resolution 7R6-v, adopted on December 21, 2022 awarded a contract to Ehrlich Petriello Gudin Plaza and Reed, P.C., 60 Park Place, Suite 1016, Newark, New Jersey 07102 to provide legal services concerning Litigation Defense Matters, in an amount not to exceed One Hundred Thousand Dollars and Zero Cents (\$100,000.00), for a period of January 1, 2023 through December 31, 2023; and

WHEREAS, Ehrlich Petriello Gudin Plaza and Reed, P.C. on or about November 2023 expended the \$100,000.00 and continued to provide legal services at the request of the Corporation Counsel for the remainder of the contract period; and

WHEREAS, the outstanding legal invoices require an increase in the total contract amount of \$22,318.28; and

WHEREAS, the requested increase in the total contract amount is deemed reasonable and necessary to pay the outstanding legal bills through the remainder of the contract period; and

WHEREAS, the increase of an additional Twenty-Two Thousand Three Hundred Eighteen Dollars and Twenty-Eight Cents (\$22,318.28), brings the total contract to an amount not to exceed One Hundred Twenty-Two Thousand Three Hundred Eighteen Dollars and Twenty-Eight Cents (\$122,318.28) for January 1, 2023 through December 31, 2023; and

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor of the City of Newark and/or his designee, the Corporation Counsel, are hereby authorized on behalf of the City of Newark to enter into and execute a First Amendment to the Agreement to provide legal services with Ehrlich Petriello Gudin Plaza and Reed, P.C., 60 Park Place, Suite 1016, Newark, New Jersey 07102, to continue providing legal services concerning Litigation Defense matters for an additional Twenty-Two Thousand Three Hundred Eighteen Dollars and Twenty-Eight Cents (\$22,318.28) for a total contract amount not to exceed One Hundred Twenty-Two Thousand Three Hundred Eighteen Dollars and Twenty-Eight Cents (\$122,318.28) for the period of January 1, 2023 through December 31, 2023, to cover the outstanding legal invoices from on or about November 1, 2023 December 31, 2023.
- 2. The Municipal Council hereby ratifies this First Amendment to the Agreement to provide legal services from November 1, 2023 to the date of the adoption of this Resolution.
- 3. All other terms and conditions of the Contract shall remain the same.
- 4. The funds for this First Amendment to the Agreement to provide Legal Services shall be paid from the City of Newark Budget/Law Department, after the issuance of a Certification of Funds from the Chief Financial Officer, which states that funds in the amount of Twenty-Two Thousand Three

Hundred Eighteen Dollars and Twenty-Eight Cents (\$22,318.28), Line NW011, Department 046, Division 0461, Account 71260, Budget 2023 are available in the aforementioned Law Department Budget. The Certification of Funds shall be filed along with the original Resolution in the Office of the City Clerk.

- 5. The Corporation Counsel shall file a copy of the executed First Amendment to the Agreement to provide legal services herein authorized in the Office of the City Clerk and the same shall be made available for public inspection.
- 6. A notice of this action shall be published in the newspaper authorized by law to publish a legal advertisement and as required by law within ten (10) days of the adoption of this Resolution.

<u>STATEMENT</u>

This Resolution ratifies, amends, and authorizes the Mayor of the City of Newark and/or his designee, the Corporation Counsel, to enter into and execute a First Amendment to the Agreement to provide legal services as counsel for Litigation Defense matters with Ehrlich Petriello Gudin Plaza and Reed, P.C. for an additional \$22,318.28 for a total contract amount not to exceed (\$122,318.28), for the period of January 1, 2023 through December 31, 2023.
