WHEREAS, the City of Newark is involved in ongoing legal matters and therefore has a need to acquire legal services; and

WHEREAS, Ricci Fava, LLC is involved in on-going legal matters for the City of Newark; and

WHEREAS, the City of Newark is desirous of continuing to utilize the services of Ricci Fava,

LLC, in the on-going legal matters and new matters that may arise; and

WHEREAS, Ricci Fava, LLC, with offices located at 45 Bleeker Street, Newark, New Jersey 07102, submitted a proposal and it was found, based upon price and other factors, to be in the best interest of the City of Newark to accept the proposal for the purpose of providing legal services concerning Litigation/Conflict Counsel; and

WHEREAS, the City of Newark wishes to enter into a new contract with Ricci Fava, LLC, to provide legal services concerning Litigation/Conflict Counsel Matters, in an amount not to exceed Fifty Thousand Dollars (\$50,000.00), for the period of January 1, 2013 through December 31, 2013, which shall cover those existing matters currently being handled by Ricci Fava, LLC, as well as new matters that may arise during the contract term; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that notice of the award of contracts for "Professional Services" without competitive bidding must be published in a local newspaper; and

WHEREAS, this contract is for an amount over \$17,500 and is being awarded as a non-fair and open contract pursuant to N.J.S.A. 19:44A-20.5; and

WHEREAS, the Mayor of the City of Newark signed into law Executive Order Number MEO-07-0001 (hereinafter "Pay-to-Play Executive Order"), which requires reporting of political contributions to Newark Municipal Candidates and prohibits certain political contributions during the duration of the contract.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Mayor of the City of Newark and/or his designee, the Corporation Counsel, are hereby authorized and directed on behalf of the City of Newark to execute a contract with Ricci Fava, LLC, 45 Bleeker Street, Newark, New Jersey 07102, to provide legal services concerning Litigation/Conflict Matters, in an amount not to exceed Fifty Thousand Dollars (\$50,000.00), for the period of January 1, 2013 through December 31, 2013, which shall cover those existing matters currently being handled by Ricci Fava, LLC, as well as new matters that may arise during the contract term.
2. The term of this contract shall be January 1, 2013 through December 31, 2013 for such matters that may arise during the contract term.
3. This contract is being awarded pursuant to the non-fair and open procedures of the State Pay-to-Play Law (N.J.S.A. 19:44A-20.5) and pursuant to the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-5(1)(a)(i)) and is in compliance with Executive Order MEO-07-0001, effective March 31, 2007.
4. The Municipal Council hereby ratifies the award of this contract from January 1, 2013 to the date of adoption of this authorizing Resolution.
5. This is an open-ended contract to be used as needed during the term of the contract. Thus, for any and all expenditures against this contract, a certification of the availability of

sufficient funds, as required by N.J.A.C. 5:30-5.5(b)(2), shall be executed before a contractual liability is incurred each time an order is placed, covering the amount of the order. Funds for this contract in the amount not to exceed Fifty Thousand Dollars (\$50,000.00), shall be provided from the City of Newark Budget, Law Department.

6. A copy of the executed agreement herein authorized shall be filed in the Office of the City Clerk by the Corporation Counsel and shall be made available for public inspection.
7. A notice of this action shall be published in the newspaper authorized by law to publish a legal advertisement and as required by law within ten (10) days of the adoption of this Resolution.

STATEMENT

This resolution authorizes and ratifies the actions of the Mayor of the City of Newark and/or his designee, the Corporation Counsel, to enter into a contract for legal services for Litigation/Conflict Matters with Ricci Fava, LLC, 45 Bleeker Street, Newark, New Jersey 07102, in an amount not to exceed Fifty Thousand Dollars (\$50,000.00), for the period of January 1, 2013 through December 31, 2013.
