**Title:** AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY REVISING EXISITING PERMIT PARKING HOURS ON NORTHSIDE OF BLEEKER STREET, BETWEEN DR. MARTIN LUTHER KING, JR. BOULEVARD AND UNIVERSITY AVENUE, EXTENDING APPROXIMATELY 165 FEET WEST FROM INTERSECTION OF UNIVERSITY AVENUE. (CENTRAL WARD)

**AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY REVISING EXISITING PERMIT PARKING HOURS ON NORTHSIDE OF BLEEKER STREET, BETWEEN DR. MARTIN LUTHER KING, JR. BOULEVARD AND UNIVERSITY AVENUE, EXTENDING APPROXIMATELY 165 FEET WEST FROM INTERSECTION OF UNIVERSITY AVENUE. (CENTRAL WARD)**

**WHEREAS,** The Newark Parking Authority has submitted a request to the City of Newark requesting to revise the Permit Parking on Northside of Bleeker Street, between Dr. Martin Luther King, Jr. Boulevard and University Avenue, extending approximately 165 feet west from intersection of University Avenue, from 24hrs./Day to 6:00 p.m. through 6:00am/Days, Monday-Sunday, in the Central Ward.

**NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

**Section 1.** That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by deleting the following:

**Northside of Bleeker Street, between Dr. Martin Luther King, Jr. Boulevard and University Avenue, approximately 165 feet west from intersection of University Avenue  
(Hours: 24hrs. / Days: Monday-Sunday)**

**Section 2.** That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

**Northside of Bleeker Street, between Dr. Martin Luther King, Jr. Boulevard and University Avenue, approximately 165 feet west from intersection of University Avenue  
(Hours: 6:00 p.m. to 6:00 a.m. / Days: Monday-Saturday)  
(Hours: 24hrs. / Days: Sunday)**

**Section 3.** Regulatory signs shall be erected and maintained by the City of Newark.

**Section 4.** Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.

**Section 5.** This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.

**Section 6.** This ordinance does not require approval by the Commissioner of Transportation.

### **STATEMENT**

This ordinance revises the parking by permit only hours on Northside of Bleeker Street between Dr. Martin Luther King, Jr. Boulevard and University Avenue, extending approximately 165 feet west from intersection of University Avenue. (Central Ward)
