# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Municipal Council does hereby authorize the honorary and ceremonial renaming to the intersection of Avon Avenue and South 10<sup>th</sup> Street as "Robert S. Vining, Jr. Way".
- 2. The official name of the said streets shall remain Avon Avenue and South 10<sup>th</sup> Street in their entirety.
