**WHEREAS**, pursuant to N.J.S.A. 40A:9-120, John L. Nikoe, of 469 Hawthorne Avenue, Newark, New Jersey 07112, was appointed as a Constable pursuant to Resolution 7R8-b, adopted at the February 22, 2019, Regular Municipal Council Meeting; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-125, John L. Nikoe, of 469 Hawthorne Avenue, Newark, New Jersey 07112, must give a Bond, in such form and amount as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The term of the Constable appointment of John L. Nikoe, of 469 Hawthorne Avenue, Newark, New Jersey 07112, is for a term of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
2. The Constable Bond in the amount of \$1,000.00 issued to John L. Nikoe, of 469 Hawthorne Avenue, Newark, New Jersey 07112, is approved as to form, amount, and sufficiency.
