This Resolution authorizes the City of Newark to apply for grant funding in the amount of \$855,942.00 and to accept any lesser or greater amount from the NJDOT 2025 Transit Village Grant Program, with no municipal funds required.

WHEREAS, the State of New Jersey Department of Transportation (“NJDOT”) FY 2025 Transit Village Grant Program provides municipalities with grant funding for transportation improvements; and

WHEREAS, the City of Newark (the “City”) seeks to obtain funding from the FY 2025 Transit Village Grant Program, to provide transportation improvements within the designated Transit Village Area; and

WHEREAS, the City intends to further the public interest by obtaining funding from the NJDOT FY 2025 Transit Village Grant Program for the construction of transportation improvements within the designated transit village area (the “Branch Brook Park Transit Village”); and

WHEREAS, the Acting Director of the Department of Engineering will submit an application on July 1, 2024, on behalf of the City of Newark, identified as TV-2025 Branch Brook Park Transit Village -00002, to NJDOT requesting grant funding in the amount of **Eight Hundred Fifty-five Thousand Nine Hundred Forty-Two Dollars and Zero Cents (\$855,942.00)**, from the NJDOT FY 2025 Transit Village Grant Program, for construction of the Branch Brook Park Transit Village Project; and

WHEREAS, pursuant to the terms of the grant application, a copy of which is attached hereto, the City of Newark is required to submit a Resolution from the Municipal Council authorizing submission of the grant application; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application, the Acting Director of the Department of Engineering desires to accept the grant award and execute a Grant Agreement governing said award; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application, the Acting Director of the Department of Engineering shall submit a copy of the Grant Agreement to the City Clerk, the Corporation Counsel and the Business Administrator for review, approval, and signature.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Mayor of the City of Newark and/or his designee, the Acting Director of the Department of Engineering, are hereby authorized to submit an electronic grant application, identified as TV-2025 Branch Brook Park Transit Village-00002, to the New Jersey Department of Transportation, on behalf of the City of Newark, requesting grant funding in the amount of **Eight Hundred Fifty-Five Thousand Nine Hundred Forty-Two Dollars and Zero Cents (\$855,942.00)** from the NJDOT FY 2025 Transit Village Grant Program, for construction of the Branch Brook Park Transit Village project in the City of Newark, with no City funds required (a copy of the application is attached hereto and made a part hereof.)

2. The Municipal Council hereby ratifies its authorization of this application from the date of application submission to the date of adoption of this authorizing Resolution.
3. The Municipal Council of the City of Newark recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Transportation, does further authorize the execution of any such grant agreement upon review, approval and signature by the City's Mayor and Corporation Counsel; and also, upon receipt of the fully executed agreement from the Department, does further authorize the acceptance of the grant funds and the expenditure of the funds pursuant to the terms of the agreement between the City of Newark and the New Jersey Department of Transportation.
4. Upon notification of the receipt of a grant award in connection with this application, the Mayor of the City of Newark and/or his designee, the Acting Director of the Department of Engineering, are hereby authorized to enter into and execute grant documents with the New Jersey Department of Transportation to receive and expend the grant award from the NJDOT FY 2025 Transit Village Grant Program, for construction of the Branch Brook Park Transit Village project in the City of Newark.
5. Upon notification of the receipt of a grant award in connection with this application, the Acting Director of the Department of Engineering shall submit a complete copy of the Grant Agreement and any associated documents to the City Clerk, Corporation Counsel and the Business Administrator for review, approval, and signature.

6. No municipal funds are required for receipt or acceptance of this grant award.
7. The Acting Director of the Department of Engineering shall file a fully-executed copy of the grant application, grant award letter, and grant agreement in the Office of the City Clerk.
