WHEREAS, the Newark Municipal Council has indicated its support for this wholesome event for the benefit of Newark residents by approving this Hold Harmless and Indemnification Agreement with the Essex County Department of Parks, Recreation and Cultural Affairs, 115 Clifton Avenue,

Newark, New Jersey 07104.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Municipal Council of the City of Newark supports the issuance of a Hold Harmless and Indemnification Agreement, drawn by the City of Newark Insurance Fund Commission for the benefit of the Essex County Department of Parks, Recreation and Cultural Affairs, 115 Clifton Avenue, Newark, New Jersey 07104, for any claims arising out of the City of Newark's use of Branch Brook Park (3 Diamonds), Newark, New Jersey 07104 for the 2013 Battle of the Badges Softball Tournament on Saturday, August 9, 2014 and Sunday, August 10, 2014, from 10:00 A.M. to 10:00 P.M.
2. The City Clerk, on behalf of the Newark Municipal Council, shall forward a true copy of the Hold Harmless and Indemnification Agreement to Essex County Department of Parks, Recreation and Cultural Affairs, 115 Clifton Avenue, Newark, New Jersey 07104 for their records.
