AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING IVY STREET, BOTH SIDES, BETWEEN SANDFORD AVENUE AND STUYVESANT AVENUE. (WEST WARD)

WHEREAS, the residents of Ivy Street have submitted a petition for Permit Parking on Ivy Street, both sides, between Sandford Avenue and Stuyvesant Avenue, in the West Ward; and

WHEREAS, the Department of Engineering wishes to improve parking for the residents of Ivy Street by creating Residential Permit Parking requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

Section 1. That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

Ivy Street, both sides between Sandford Avenue and Stuyvesant Avenue (Hours: 7:00a.m.-4:00p.m. / Days: Monday-Friday)

Section 2. Regulatory signs shall be erected and maintained by the City of Newark.

Section 3. Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.

Section 4. This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.

Section 5. This ordinance does not require approval by the Commissioner of Transportation.

STATEMENT

This ordinance allows the Department of Engineering to improve parking for residents on Ivy Street, both sides, by creating "Parking by Permit Only", between Sandford Avenue and Stuyvesant Avenue. (West Ward)
