WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$1,721,729.63 for Newark Ironbound Roundabout Project Grant and no adequate provision has

been made in the 2024 Temporary Budget for the aforesaid purpose; and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

WHEREAS, by Resolution 7R3-b adopted on December 6, 2023, the City of Newark accepted funds from the New Jersey Department of Transportation, in the amount of \$1,721,729.63, to provide for Newark Ironbound Roundabout Project Grant for City of Newark; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, emergency appropriation adopted in 2024, pursuant to N.J.S.A. 40A:4-20 including this Resolution total...\$ 344,701,274.19.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. No less than two-thirds of all members thereof are affirmatively concurring,
2. An emergency appropriation be and the same is hereby made for the following classification:

3. Said emergency appropriation shall be provided for in the 2024 Budget.
4. A copy of this Resolution shall be immediately filed with the City Clerk by the Budget Director of the City of Newark.
