NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Duane Mickens, 146 Brookdale Avenue, Newark, New Jersey 07106, be and is hereby appointed as a Constable, for a three (3) year term, in accordance with his application to serve lockouts, subpoenas and official court documents.
- 2. Prior to entering upon the execution of his office and no later than thirty (30) days after effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by Resolution of the Newark Municipal Council.
- 3. This appointment shall be for a period of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
