1. The date of the Constable appointment of Ronnie Eugene Kellam, of 134 North 13<sup>th</sup> Street, 1<sup>st</sup> Floor, Newark, New Jersey 07107, is amended from March 2, 2016 to an appointment date of April 18, 2016 for a term of three (3) years.
2. The Resolution 7R9-a, adopted on March 2, 2016, Regular Municipal Council Meeting is hereby amended accordingly.
