**WHEREAS**, the City of Newark, Department of Engineering, Division of Traffic and Signals, advertised for receipt of bids on September 21, 2017, for Contract No. 2017, Various Streets-2016 (10 Locations) MA-16 Newark Project; and

**WHEREAS**, on October 12, 2017, the Department of Engineering received Seven (7) bids for Contract No. 2017-01, Various Streets-2016 (10 Locations) MA-16 Newark Project, in accordance with Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, based on a review of the bid received from Granada Construction Corp., 147 Thomas Street, Newark, New Jersey 07114, the Department of Engineering identified a miscalculation in line item 20, which resulted in Granada Construction Corp. no longer being considered as the lowest bidder; and

**WHEREAS**, based on a review of the remaining bids, the Director of the Department of Engineering, desires to accept the bid proposal submitted by the lowest responsible bidder, J.A. Alexander, Inc., 130-158 John F. Kennedy Drive North, Bloomfield, New Jersey 07003, and execute Contract No. 2017-01, Various Streets-2016 (10 Locations) MA-16 Newark Project with them, for an amount not to exceed \$2,293,437.72.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Mayor and/or his designee, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark to accept the bid proposal submitted by the lowest responsible bidder, J.A. Alexander, Inc., 130-158 John F. Kennedy Drive North, Bloomfield,

New Jersey 07003, and execute Contract No. 2017-01, Various Streets-2016 (10 Locations) MA-16 Newark Project, for an amount not to exceed \$2,293,437.72 for a term of 365 consecutive calendar days from the issuance of the Notice to Proceed.

- Attached hereto are Certifications of Funds issued by the Director of Finance, which states: (1) that there are available sufficient, legally appropriated funds in the amount of \$2,293,437.72, for the purpose set forth hereinabove; and (2) the line appropriation of the official budget which shall be charged is as follows:
