**AN ORDINANCE AMENDING SECTION 23:5-5.1, FOUR HOUR PARKING FOR NONRESIDENTIAL VEHICLES, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING BRUEN STREET.**

**WHEREAS, the Division of Traffic and Signals as per the request of the business owners wishes to limit parking to four (4) hours on both sides of Bruen Street, in the East Ward, between Green Street and Lafayette Street for vehicles without a residential parking permit; and**

**WHEREAS, the parking limitation will increase and improve traffic flow and encourage parking space turnover for residents, businesses and customers.**

**NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

**Section 1.** That Section 23:5-5.1, Four Hour Parking for Nonresidential Vehicles, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, as amended and supplemented, be amended by adding thereto the following:

**Bruen Street, between Lafayette Street and Green Street  
Both sides, 9:00 a.m. to 5:00 p.m., Monday through Friday**

**Section 2.** Any existing ordinances or parts thereof inconsistent with this ordinance are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.

**Section 4.** This ordinance does not require approval by the Commissioner of Transportation.

**Statement**

This ordinance limits vehicles that do not possess a residential permit to a four (4) hour parking limitation at any of the parking spaces along both sides of Bruen Street between Lafayette Street and Green Street from 9:00 a.m. to 5:00 p.m., Monday through Friday, in the East Ward. Vehicles with a permit shall be exempt from the time limitations and parking meter fees.
