WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$1,888,537.00 for the Urban Areas Security Initiative Grant Program and no adequate provision has been made in the 2012 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A: 4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

WHEREAS, by Resolution 7R11-b dated February 1, 2012, \$1,834,537.00 and Resolution 7R11-a dated June 7, 2012, \$54,000.00 the City of Newark accepted the Urban Areas Security Initiative (UASI) Grant in the amount of \$1,888,537.00 for equipment and training to enhance the City of Newark's ability to prevent, protect against and respond to and recover from acts of terrorism and other catastrophic events and emergencies and to partially fund a Metro Strike Team Equipment Manager position; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, emergency appropriation adopted in 2012 pursuant to <u>N.J.S.A.</u> 40A:4-20 including this resolution total....\$258,651,969.63

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. A temporary emergency appropriation be and the same is hereby made for the following classification:

Urban Areas Security Initiative Grant Program \$1,888,537.00

- 2. Said emergency appropriation shall be provided for in the 2012 budget.
- 3. A copy of this resolution shall be immediately filed with the Director of Local Government Services by the Budget Director of the City of Newark.
