AN ORDINANCE AMENDING SECTION 23:7, PARKING METER REGULATIONS, GENERALLY, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS PREVIOUSLY AMENDED AND SUPPLEMENTED, BY REVISING THE PARKING METER RATES IN SECTION 23:7-13.

WHEREAS, the Department of Engineering, Division of Traffic and Signals, together with the Newark Parking Authority, City of Newark, desires to revise the parking meter rates for parking throughout Zones 1, 2 and 3.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

Section 1. The above recitals are hereby incorporated into the body of this Ordinance as if fully set forth herein.

Section 2. Section 23:7, Parking Meter Regulations, Generally, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, as amended and supplemented, shall be and is hereby amended by revising the parking meter rates set forth in Section 23:7-13 as follows, and all other provisions in the Ordinance shall remain in effect:

[Note: Bold and underlined text represents additions and strikethroughs represent deletions.]

23:7-13 METER RATES

Zone 1. All the streets in the central business district as defined in Section 23:1-1, excluding therefrom those streets or portions thereof enumerated in Sections 23:5-4 and 23:5-5, the rates shall be as follows:

One Quarter	45 <u>10</u> minutes
Two Quarters	30 <u>20</u> minutes
Three Quarters	45 <u>30</u> minutes
Four Quarters	60 <u>40</u> minutes
<u>Five Quarters</u>	<u>50 minutes</u>
<u>Six Quarters</u>	<u>60 minutes</u>

Zone 2.

a. For those streets or portions thereof, where parking is limited to one (1) hour, as enumerated in Section 23:5-4, the rates shall be as follows:

One Quarter	45 <u>10</u> minutes
Two Quarters	30 <u>20</u> minutes
Three Quarters	45 <u>30</u> minutes
Four Quarters	60 <u>40</u> minutes
<u>Five Quarters</u>	<u>50 minutes</u>
<u>Six Quarters</u>	<u>60 minutes</u>

b. For those streets or portions thereof, where parking is limited to two (2) hours, as enumerated in Section 23:5-5, the rates shall be as follows:

One Quarter	45 <u>10</u> minutes
Two Quarters	30 <u>20</u> minutes
Three Quarters	45 <u>30</u> minutes
Four Quarters	60 <u>40</u> minutes
Five Quarters	75 <u>50</u> minutes
Six Quarters	90 <u>60</u> minutes
Seven Quarters	105 <u>70</u> minutes
Eight Quarters	120 <u>80</u> minutes
Nine Quarters	<u>90</u> minutes
<u>Ten Quarters</u>	<u>100 minutes</u>
<u>Eleven Quarters</u>	<u>110 minutes</u>

Twelve Quarters

120 minutes

c. For those streets or portions thereof where parking is limited to thirty (30) minutes, as enumerated in Section 23:5-4.1, the rates shall be as follows:

One Quarter ~~45~~**10** minutes

Two Quarters ~~30~~**20** minutes

Three Quarters

30 minutes

d. For those streets or portions thereof where parking is limited to fifteen (15) minutes, as enumerated in Section 23:5-4.2, the rates shall be as follows:

One Quarter ~~45~~**10** minutes

Zone 3.

a. For those streets or portions thereof, where parking is limited to eight (8) hours the rates shall be as follows:

One Quarter ~~45~~**10** minutes

b. For those streets or portions thereof, where parking is limited to four (4) hours the rates shall be as follows:

One Quarter ~~45~~**10** minutes

c. For those streets or portions thereof, where parking is limited to two (2) hours as enumerated in this section 23:7-13, the rates shall be as follows:

One Quarter ~~45~~**10** minutes

Section 3. Any prior Ordinances or parts thereof which are inconsistent with the terms herein are hereby repealed.

Section 4. If any part of this Ordinance is declared unconstitutional or illegal, the remaining provisions hereof shall continue in full force and effect.

Section 5. This Ordinance shall take effect upon final passage and publication in accordance with the laws of the State of New Jersey.

Section 6. This Ordinance shall not require approval by the Commissioner of Transportation.

STATEMENT

This Ordinance amends Title 23, Section 23:7, Parking Meter Regulations, Generally, Traffic and Parking, of the Revised General Ordinances of the City of Newark and establishes revised Parking Meter Rates for parking throughout Zones 1, 2 and 3.
