**WHEREAS,** pursuant to *N.J.S.A.* 40A:9-120 et seq., the City of Newark is authorized to appoint up to fifty (50) Constables to establish the term for such appointment at one (1) or three (3) years; and

WHEREAS, the City of Newark wishes to implement the three (3) year option.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. Shawn W. Reeves, 2 Keer Avenue, Newark, New Jersey 07112, be and is hereby appointed

as a Constable, in accordance with his application to serve warrants.

- 2. Prior to enter upon the execution of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by resolution of the Newark Municipal Council.
- 3. This appointment shall be for a period of three (3) years from the date of the appointment or the expiration of the Constable Bond, whichever occurs first.

### **STATEMENT:**

This resolution hereby authorizes the appointment of Shawn W. Reeves, 2 Keer Avenue, Newark, New Jersey 07112, to serve as a Constable in the City of Newark, New Jersey.
