**WHEREAS,** the City of Newark wishes to appoint Timothy Aaron Davis, as a Constable, for a three (3) year term pursuant to N.J.S.A. 40A:9-121.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Timothy Aaron Davis, of 117 Schuyler Avenue, Newark, New Jersey 07112, is hereby appointed as a Constable, in accordance with his application to serve writs, summonses, subpoenas and complaints.
- 2. Prior to entering upon the execution of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Newark Municipal Council.
- 3. This appointment shall be for a period of three (3) years from the date of the appointment or to the expiration of the Constable Bond, whichever occurs first.

## **STATEMENT**
