WHEREAS, on June 25, 2022, on behalf of the City, the Acting Director of the Department of Engineering submitted an application to NJDOT requesting grant funding in the amount of Five Million Nine Hundred Three Thousand Seven Hundred Sixty-Four Dollars and Zero Cents (\$5,903,764.00) from the NJDOT Municipal Aid Program for Street Resurfacing within the City, identified as application MA-2023 - Various Streets 2023 for the City of Newark with no City funds required; and

WHEREAS, pursuant to the terms of the grant application, a copy of which is attached hereto, the City of Newark is required to submit a Resolution from the Municipal Council authorizing submission of the grant application; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application, the Acting Director of the Department of Engineering desires to accept the grant award and execute a Grant Agreement governing said award; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application MA-2023 - Various Streets 2023 for the City, the Acting Director of the Department of Engineering shall submit a copy of the Grant Agreement to the City Clerk, Corporation Counsel and the Business Administrator.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Municipal Council formally approves the grant application for MA-2023 Various Streets 2023 for the City of Newark with no City funds required.
- 2. The Mayor of the City of Newark and/or his designee, the Acting Director of the Department of Engineering are hereby authorized to submit an electronic grant application identified as MA-2023 Various Streets 2023 on behalf of the City of Newark to the New Jersey Department of Transportation requesting grant funding in the amount of Five Million Nine Hundred Three Thousand Seven Hundred Sixty-Four Dollars and Zero Cents (\$5,903,764.00) from the NJDOT Municipal Aid Program for Street Resurfacing Various Streets 2023 Newark, MA-23 (a copy of the application is attached hereto and made a part hereof).
- 3. The Municipal Council hereby ratifies its authorization of this application from the date of application submission to the date of adoption of this authorizing Resolution.
- 4. Upon notification of the receipt of a grant award in connection with this application, the grant is hereby accepted.
- 5. Upon notification of the receipt of a grant award in connection with this application, the Mayor of the City of Newark and/or his designee, the Acting Director of the Department of Engineering, are hereby authorized to enter into and execute grant documents with the NJDOT to receive and expend the grant award from the NJDOT Municipal Aid Program for Street Resurfacing Various Streets 2023 Newark, MA-23.
- 6. Upon notification of the receipt of a grant award in connection with this application, the Acting Director of the Department of Engineering shall submit a complete copy of the Grant Agreement and any associated documents to the City Clerk, Corporation Counsel and the Business Administrator for review, approval, and signature.
 - 7. No municipal funds are required for receipt or acceptance of this grant award.
- 8. The Acting Director of the Department of Engineering shall file a fully executed copy of the grant application, grant award letter, and grant agreement in the Office of the City Clerk.
