- 1. Shadid Jamal Webb, 54 Vermont Avenue Avenue, Newark, New Jersey 07106, be and is hereby appointed as a Constable, in accordance with his application to serve warrants, evictions and security detail.
- 2. Prior to entering upon the execution of his office and no later than thirty (30) days after effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by Resolution of the Newark Municipal Council.
