**WHEREAS**, an emergency has arisen in Special Item of Appropriation in the amount of \$3,606,497.00 for the Homeless HRSA Program Grant, and no adequate provision has been made in the 2021 Temporary Budget for the aforesaid purpose, and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the same; and

**WHEREAS**, by a Notice of Award dated November 23, 2020, the U.S. Department of Health and Human Services/Health Resources and Services Administration (HRSA) has awarded the City of Newark the Homeless HRSA Program Grant in the amount of \$3,606,497.00, to provide medical care, social services, substance abuse and mental health counseling to the homeless population within the City of Newark and surrounding areas; and

**WHEREAS,** a previous resolution authorizing TE #16 and prior appropriations submitted for Municipal Council approved totaled \$140,456,062.36; and

**WHEREAS,** N.J.S.A. 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS,** emergency appropriations adopted in 2021 pursuant to <u>N.J.S.A.</u> 40A:4-20, including this resolution, total ......\$144,062,559.36

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Governing Body by a two-thirds vote of its full membership hereby amends its temporary budget by making the following emergency appropriation.
- 2. A temporary emergency appropriation be and the same is hereby made for the following classification:
