**WHEREAS**, through Mrs. Mincy's positive attitude and willingness to sacrifice her own peace

of mind for the children and the community of Avon Avenue and South 15<sup>th</sup> Street, we will be forever grateful for her caring hand and comforting smile.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Municipal Council hereby authorizes the honorary and ceremonial renaming of the intersection of Avon Avenue and South 15<sup>th</sup> Street as "Hazel Mincy Way".
2. The official name of the said streets shall remain Avon Avenue and South 15<sup>th</sup> Street in their entirety.
