**WHEREAS**, on October 5, 2018, on behalf of the City of Newark, the Director of the Department of Engineering submitted an electronic application to NJDOT requesting grant funding in the amount of \$3,667,382.00 from the NJDOT Municipal Aid Program for Street Resurfacing - Various Streets - 2019 - Newark (35 locations, MA-19) within the City of Newark, identified as application MA-2019-VARIOUS STREETS-2019 (35 LOCATIONS) - 00688 for City of Newark with no City funds required; and

**WHEREAS**, pursuant to the terms of the grant application, a copy of which is attached hereto, the City of Newark is required to submit a resolution from the Newark Municipal Council authorizing submission of the grant application; and

**WHEREAS**, upon notification of the receipt of a grant award in connection with this application, the Director of the Department of Engineering desires to accept the grant award and execute a grant agreement governing said award; and

**WHEREAS**, upon notification of the receipt of a grant award in connection with this application MA-2019-VARIOUS STREETS-2019 (35 LOCATIONS) -00688 for City of Newark, the Director of Department of Engineering shall submit a copy of the grant agreement to the City Clerk, Corporation Counsel and the Business Administrator for review, approval, and signature.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Mayor and/or his designees, the Director of the Department of Engineering are hereby authorized to submit an electronic application, identified as MA-2019-VARIOUS STREETS-2019 (35 LOCATIONS) - 00688 for City of Newark to the New Jersey Department of Transportation (“NJDOT”), on behalf of the City of Newark requesting grant funding in the amount of \$3,667,382.00 from the State Aid to Counties and Municipalities FY2019 Municipal Aid Program (“NJDOT Municipal Aid Program”) for Street Resurfacing - Various Streets - 2019 - Newark (35 locations, MA-19) within the

City of Newark with no City funds required (a copy of the application is attached hereto and made a part hereof).

2. The Municipal Council hereby ratifies its authorization of this application from the date of application submission to the date of adoption of this authorizing resolution.
3. Upon notification of the receipt of a grant award in connection with this application, the grant is hereby accepted.
4. Upon notification of the receipt of a grant award in connection with this application, the Mayor and/or his designees, the Director of the Department of Engineering and the City Clerk, are hereby authorized to enter into and execute grant documents with the NJDOT to receive and expend the grant award for Street Resurfacing - Various Streets - 2019 - Newark (35 locations, MA-19) within the City of Newark.
5. Upon notification of the receipt of a grant award in connection with this application, the Director of the Department of Engineering shall submit a complete copy of the grant agreement and any associated documents to both the Corporation Counsel and the Business Administrator for review, approval, and signature.
6. No municipal funds are required for receipt or acceptance of this grant award.
7. The Director of Department of Engineering shall file a fully-executed copy of the grant application, the grant award letter, and the grant agreement in the Office of City Clerk.
