**WHEREAS,** an emergency has arisen in the Special Item of Appropriation in the amount of \$242,000.00 for Workforce Learning Link (WLL) Program 2018 and no provision has been made in

the 2018 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose abovementioned; and

**WHEREAS**, by an award letter dated June 30, 2017 from the State of New Jersey, Department of Labor and Workforce Development, the City was awarded Workforce Learning Link Program 2018 in the amount of \$242,000.00 to provide funds for program operations; and

**WHEREAS**, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, the emergency appropriations adopted in 2018 pursuant to N.J.S.A. 40A:4-20 including this resolution total \$5,182,709.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. An emergency appropriation be and the same is hereby made for the following classification:

2. Said emergency appropriation shall be provided for in the 2018 budget.
