**WHEREAS**, pursuant to Resolution 7R1-A(S), authorized on January 11, 2011, the City of Newark appropriated \$232,914.00 in Community Development Block Grant (CDBG) funds to Branch Brook Park Alliance (hereinafter referred to as the Sub-recipient) to provide physical rehabilitation services to the public facility located at Branch Brook Park Music Court Pavilion in Newark, NJ, North Ward; and

WHEREAS, pursuant to Resolution 7R1-C, authorized on September 8, 2011, the Municipal Council authorized the Mayor and/or his designee, the Business Administrator to enter into and execute contract with the Sub-recipient to provide physical rehabilitation services to the public facility located at Branch Brook Park Music Court Pavilion in Newark, NJ, North Ward, for the contract period January 1, 2011 - December 31, 2011, in an amount not to exceed \$232,914.00; and

**WHEREAS**, the Sub-recipient has requested authorization to extend the contract period to complete this project from January 1, 2011-December 31, 2011 to January 1, 2011-December 31, 2012; and

**WHEREAS**, this project does not require the use of additional funds and all other terms and conditions contained in contract authorized under Resolution 7R1-C 090811 shall remain in full effect.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor and/or his designee, the Deputy Mayor/Director of the Department of Economic and Housing Development, are hereby authorized to enter into and execute a First Amended Agreement, in the form attached hereto, with Branch Brook Park Alliance, Inc., (hereafter referred to as the Sub-recipient) which will amend the term of the contract from January 1, 2011-December 31, 2011 to January 1, 2011-December 31, 2012, to allow the sub-recipient to complete the physical rehabilitation services to the public facility located at Branch Brook Park Music Court Pavilion in Newark, NJ, North Ward.
- 2. The First Amended Agreement between the City of Newark and the sub-recipient is hereby ratified from January 1, 2011 to the date of adoption of this authorizing resolution.
- 3. This resolution and a fully executed copy of the First Amended Agreement shall be filed with the Office of the City Clerk by the Deputy Mayor/Director of the Department of Economic and Housing Development.
- 4. This project does not require the use of additional funds and all other terms and conditions contained in the Agreement authorized pursuant to Resolution 7R1-C 090811 shall remain in full effect and in accordance with the law.
