- 1. Andre Jenkinson, of 52 Cypress Street, Newark, New Jersey 07108, be and is hereby appointed as a Constable, in accordance with his application to serve eviction notices, subpoenas and lockouts.
- 2. Prior to enter upon the execution of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by resolution of the Newark Municipal Council.
